Citations

When the author's name is in the text (CMS 16.112):

In a study by Brown (1987) . . .

When the text refers to a reference (CMS 16.112):

In this study (Garmaise and Moskowitz 1999) . . .

One citation:

(Brennan, Jegadeesh, and Swaminathan 1993)

For more than one citation:

(Rajan and Zingales 1995; Frank and Goyal 2003, 2007)
(see, e.g., Ball and Torous 1984; Lo 1986; Ait-Sahalia 1999, 2002)

For more than three authors (CMS 16.118):

In a study by Zipursky et al. (1997) . . .
The study (Zipursky et al. 1997) finds that

Surname, First initial. Forthcoming. Article title. *Journal Name*.

Surname, First initial. Year. Title of article. *Review of Financial Studies*. Advance Access published Month Day, Year, 10.1093/rfs/hhX####.

Working Paper (if you can, list the university affiliation of the first author of the working paper)

Baird, D., and D. Bernstein. 2005. Absolute priority. Working Paper, University of Chicago Law School.

Book

Book with Chapters with Editor Other than the Author
